SPECIAL EXECUTIVE BOARD MEETING MINUTES

AUGUST 25, 2022

1. Call to Order / Pledge of Allegiance / Prayer / Roll Call of Executive Board Members

At the call of the President of the Commission the notice and agenda of this Special Executive Board Meeting having been posted and published in accordance with section 2.02 of the Illinois Open Meetings Act, in the office of the Veterans' Assistance Commission of Madison County in the Madison County Administration Building located at 157 North Main Street, Suite 115, Edwardsville, IL and on the Veterans Assistance Commission's Website on August 22, 2022.

Special Executive Board Meeting called to order at 6:47 p.m. at the VAC in Edwardsville, IL by President Ronnie Hicks. The Pledge of Allegiance and Prayer were completed. President Hicks then directed the Secretary to call the roll of Executive Board Members to determine the presence of a quorum to do business.

In accordance with Art. VI, §2 of the by-laws, there being 6 or more Executive Board Members attending, President Hicks declared a quorum was present. 2. Special Meeting Business

There being none, he directed the Secretary to take a roll call vote on the motion. Upon roll call the vote was 11 in favor and 0 against. President Hicks announced the motion carried and directed that the room be re-opened for any visitors who remained.

Burkart and Burkart Law Offices as legal counsel for the VAC in accordance with, and to permit the President to execute, the retainer agreement tendered to the Board. President Hicks directed the Secretary to take a roll call vote on the motion. Upon roll call the vote was 11 in favor and 0 against. President Hicks announced the motion carried
